



Mentoring Capacity Building Support Opportunity for Mentor Center Partner Programs Guidelines- FY 2021/2022

What is the Mentoring Capacity Building Support Opportunity?

Launched in January 2014, the Mentoring Support Opportunity was conceived to help mentoring programs develop additional matches and help alleviate the wait list of mentees in Palm Beach County. Research shows that high quality, enduring relationships can lead to a range of positive outcomes for young people. Through the Mentoring Support Opportunity, United Way of Palm Beach County seeks to support capacity-building efforts that enhance the quality of mentoring programs and increase the number of youths being mentored.

Specifically, we have now seen the increase in the number of youths in the Delinquency and Dependency system(s). Through the pandemic, the needs of some of our most vulnerable youths have gone unmet. We know that matching youth with a positive adult and trusted mentor can help these youth navigate through some of the most difficult times in their young lives. For this cycle of capacity building mini grants, we are looking to engage programs that will serve this segment of youth.

For the current mini-grant opportunity, only affiliate programs that have a current active mentoring program, are willing to serve youth in the Juvenile Justice and/or Dependency system(s) and are seeking to implement all Elements of Effective Practice are eligible to apply. The typical grant is between \$2,000 up to a maximum of \$7,500 (based on available funds) to be used to expand program capacity, extend their services to serve this segment of youth, and become eligible to join the Mentor Center Network.

Who is eligible to apply?

Only 501c(3) non-profit organizations that have a current mentoring program and are seeking to implement all Elements of Effective Practice are eligible to apply.

In addition, if awarded a grant, the organization must have general liability insurance with a minimum of \$1,000,000 coverage and add United Way of Palm Beach County as an additional insured party, prior to receiving the grant award.

What can an agency receive funding for?

Funding can only be used toward programmatic implementation. Specifically, funding should go toward implementing one or more parts of the Elements of Effective Practice that are currently out of the program's financial capacity. Based on the Elements of Effective Practice for Mentoring, examples include:

- Mentor/Mentee recruitment
 - Marketing, advertising, promotional materials, events to recruit mentors
- Screening
 - Level 2 background screenings
 - Drug tests

- DMV and/or Credit Checks
- Training
 - Food and refreshments for trainings for new and prospective mentors
 - Mentor/mentee and staff trainings aimed at improving program quality
- Matching
 - Interview tool from National Mentoring Partnership
- Monitoring and Support
 - Database to store mentoring match information
 - United Way's mentor Center uses Innovative Mentoring Software
 - Data sharing software utilization (must agree to share data with the Mentor Center)
- Match Closure
 - Special lunch meeting to close the match

Funds can NOT be used for staff compensation or other agency costs not directly associated with program implementation.

How can an agency apply?

Mentoring Support Opportunity applications are available as of **March 7, 2022**. Applications must be submitted by **5:00pm on March 25, 2022**. Late applications and applications missing required information will not be accepted.

Applications with all required signatures and all supporting materials must be emailed **no later than 5:00pm on March 25, 2022** to the Mentor Center at Mentoring@unitedwaypbc.org with the following subject line: **Mentoring Support Opportunity – [Name of Organization/Program]**.

An Application Advisory Panel will review the applications and make funding recommendations to United Way of Palm Beach County's Community Impact Committee. The panel will consist of representatives from United Way of Palm Beach County and community stakeholders.

What documentation must be submitted after services have been rendered and the project is complete?

By September 30, 2022 at 5:00pm, the organization will be required to submit a *Mentoring Capacity Building Support Opportunity Report Form* to United Way of Palm Beach County. The organization will also be required to submit a financial reconciliation statement (accounting for the use of all funds), a client impact story and demographic data of mentees served. Other documentation may be requested as well.

In addition, it is strongly encouraged that program staff as well as the organization's Executive Director/CEO attend the Racial Equity Institute and Trauma Informed Care workshops. The United Way hosts several of these workshops throughout the year and programs will be notified when registration for each session is open.
